Obtaining Federal Assistance

What This Book Gives You

GOVERNMENT ASSISTANCE ALMANAC has two purposes: (1) to provide information enabling users to identify *all domestic programs offering financial or nonfinancial assistance available from federal agencies*; (2) to help users reach the point of obtaining assistance.

This twenty-second edition describes 2,023 federal programs, 495 of which were added since the last edition. The information presented is based on data in the *Catalog of Federal Domestic Assistance* (“CFDA”), maintained by the General Services Administration pursuant to federal statute.

The *ALMANAC* reduces the information in the CFDA’s approximately 3,000 pages to the essentials needed by most persons seeking federal assistance. Modifications in the presentation of the information, especially the *ALMANAC*’s indexes, enable users to identify available programs and their features more efficiently.

PART I provides *basic guidance on using this book* to identify and obtain available assistance. The guidelines are intended for newcomers to federal programs; more experienced users of similar information may find some helpful reminders.

PART II outlines *domestic financial and other assistance programs available per the CFDA as of July, 2013*. When available the following is provided for each program:

- federal program number and title; popular title when applicable;
- types of assistance available;
- description of objectives, permitted uses of funds, and project examples when they clarify program purposes; enacting legislation is noted to help define program purposes;
- eligibility factors concerning both applicants and beneficiaries;

- range and average amounts awarded through programs providing financial assistance;
- summary of recent activity;
- mailing address, phone number, and web site for program headquarters, and other referrals when applicable.

PART III provides tables showing *funding levels for all programs and administering agencies* for the last *four fiscal years*. To our knowledge such comprehensive tables showing allocations specifically for federal domestic programs are exclusive to the *ALMANAC*. Table 1 also serves as a *listing of the programs in the numerical sequence* in which they appear in PART II.

PART IV provides *addresses and phone numbers for more than 3,000 field offices*, organized to correspond with the program numbers within their purview. This system was established specifically for users of the *ALMANAC*; like the tables, this system exists nowhere else.

The **AGENCY INDEX** provides an *alphabetical listing of federal administrative units and sub-units*, including the program numbers within their purview. (The CFDA does not provide an alphabetical listing.) While administrative units also are incorporated within the MASTER INDEX, the AGENCY INDEX may expedite user searches specifically for these entities.

ALMANAC users will find the **MASTER INDEX** unique and exhaustive, particularly its subject headings, references, and cross-references. This index identifies all available federal domestic assistance programs. It also includes: administrative units and cross-references to sub-units; official and popular program titles; abbreviated program, agency, and other titles and terms; many enabling laws and their section and title numbers; and, general program references not found in other indexes of government assistance. The format enables users to distinguish programs providing financial assistance from those that do not, through the use of italicized program numbers. The copyright for *GOVERNMENT ASSISTANCE ALMANAC* makes its index an exclusive feature.

The list of **Abbreviations Used in This Book** preceding this section does not appear in the CFDA.

By definition, “domestic programs” do not necessarily include assistance available through ongoing government activities—e.g., operation of federal facilities and services, public information activities, enforcement of many federal laws and regulations, or products or services obtained through contractors, etc. The section entitled “Types of Federal Assistance Available,” beginning below, explains what assistance is and is not covered.

Encountering the information in this book for the first time, some will be surprised by the scope of available federal assistance, which may seem very broad or rather meager in many areas. The assistance is available subject to program eligibility criteria, discussed under “Who May Obtain Federal Assistance?”

Timeliness of the Information

The twenty-first edition of the *ALMANAC* identified 1,796 federal programs. Since the publication of that edition 495 programs were added and 268 were deleted, producing the present total of 2,023 as of July, 2013; this twenty-second edition incorporates the new programs, as well as many program changes.

Federal programs rarely are terminated unless similar assistance is available through another program; this book helps identify those other programs. There has been an almost steady increase in the total number of domestic programs since the mid-1980s, from 989 programs in 1984 to 2,023 programs in 2013.

Currently some 67 departments, commissions, agencies, bureaus, and other federal entities administer the assistance programs. They manage the programs either through their main offices, through 217 “administrative sub-units,” or through approximately 3,000 field offices.

Regarding the reliability of addresses and phone numbers, generally, ten to twelve percent of phone numbers and five to seven percent of office addresses change in the course of a year, based on federal directories studied. It can reasonably be expected that few changes in program contact information will be encountered.

Changes are inevitable in program application requirements, governmental organization, and addresses and phone numbers. Keeping abreast of all changes would require a daily compilation, such as is provided in the *Federal Register*. However, most substantive program changes affect the details of regulations, seldom affecting the factors included in the *ALMANAC*’s program entries; in pursuing programs with federal officials, inquirers will be advised of major changes.

Types of Federal Assistance Available

Fifteen types of federal domestic assistance are available through existing programs, providing financial or nonfinancial resources.

Programs that provide *financial assistance* are classified as:

Direct loans—offering the loan of federal funds for a specific term, with or without interest, with repayment expected. Example: FSA’s “Emer-

10.025 PLANT AND ANIMAL DISEASE, PEST CONTROL, AND ANIMAL CARE

Assistance: project grants (cost sharing).

Purposes: pursuant to the Plant Protection Act, Farm Security and Rural Investment Act of 2002 (FSRIA), and Animal Welfare Act as amended, for surveys, demonstration projects, and inspections to detect, appraise, eradicate, and control plant and animal diseases and pests injurious to agriculture, including brucellosis and tuberculosis; to ensure the safety and potency of veterinary biologics. Emphasis is on prevention of interstate spread of infestations and diseases.

Eligible applicants: foreign, state, local, and territorial government agencies; nonprofit IHEs and other organizations.

Eligible beneficiaries: in addition to applicants: farmers, ranchers, agricultural producers.

Activity: estimate, 50 states brucellosis-free, 47 tuberculosis-free.

10.028 WILDLIFE SERVICES

Assistance: project grants (cost sharing).

Purposes: pursuant to the Animal Damage Control Act of 1931 as amended, to reduce damage caused by nuisance mammals and birds, including those carrying zoonotic diseases. Project examples: predator control programs in the western states, including coyote, mountain lion, and bear; aerial blackbird hazing program protecting the sunflower crop; control of beaver, deer, and cormorants against damage to aquaculture in the eastern and southern states. Most direct technical assistance is provided through state fish and game, agriculture, and health departments.

Eligible applicants/beneficiaries: state, local, territorial, and tribal governments; public or private nonprofit organizations; nonprofit IHEs; individuals.

10.030 INDEMNITY PROGRAM

Assistance: direct payments/unrestricted use (100 percent).

Purposes: as authorized by The Animal and Plant Health Inspection Service, payment will be made for a wide variety of indemnity situations ranging from large livestock depopulations to small fowl depopulations based upon an emergency declared by the Secretary of Agriculture. Payment for the destroyed animals is based on fair market value. As authorized by Section 415 (e) of the Plant Protection Act, in the event of a declaration of extraordinary emergency due to the presence of a plant pest or noxious weed that is new to or not known to be widely prevalent in the United States, the Secretary may pay compensation for eligible economic losses.

10.051 COMMODITY LOANS AND LOAN DEFICIENCY PAYMENTS (“Price Supports”)

Assistance: direct payments/unrestricted use; direct loans (to 9 months).

Purposes: pursuant to the Agricultural Adjustment Act of 1938, Commodity Credit Corporation Charter Act, Food, Agriculture, Conservation, and Trade Act of 1990 (FACTA), Federal Agriculture Improvement and Reform Act of 1996 (FAIRA), Agricultural Risk Protection Act of 2000, amendments, and other acts, to help growers stabilize their income from commodities through a system of price supports involving loans and pur-

chases by the CCC. Producers may receive nonrecourse loans against the support price established for crops serving as loan collateral; if market prices exceed the support price, farmers may market the commodity and repay the loan principal plus interest; if market prices are low, the loan is repaid through forfeiture of the collateral to the CCC in return for a loan deficiency payment (LDP) for the difference between the support and the market prices. Commodities eligible for loans include feed grains, wheat, rice, peanuts, tobacco, upland cotton, extra-long staple cotton, sugar, soybeans, canola, flaxseed, mustard seed, rapeseed, safflower, and sunflower seed. LDPs are offered for feed grains, wheat, upland cotton, rice, soybeans, canola, flaxseed, mustard seed, rapeseed, safflower, and sunflower seed. If the loan repayment rates are less than the established loan levels, producers may forego the loan and elect to receive LDPs which are equal to the amount by which the loan rate exceeds the loan repayment rate in effect on the delivery date. Recourse loans may be made for low quality grain or unginned seed cotton; such loans require repayment at maturity.

Eligible applicants/beneficiaries: owners, landlords, tenants, or sharecroppers on farms producing eligible commodities; for sugar, processors or refiners meeting USDA program requirements.

10.053 DAIRY INDEMNITY PROGRAM

Assistance: direct payments/unrestricted use (100 percent).

Purposes: pursuant to the Agricultural Act of 1970, Agriculture and Consumer Protection Act of 1973, FACTA, amendments, and other acts, to indemnify dairy farmers and dairy product manufacturers against losses when their milk or dairy products are contaminated by pesticides, chemicals, toxic substances, or nuclear radiation or fallout, if the cause was outside their control; in such cases CCC pays the fair market value of the product.

Eligible applicants/beneficiaries: dairy farmers and manufacturers with products removed from the market by a public agency. Available also in PR.

Assistance: direct payments/specified use.

Two tables are presented:

The tables are based on information in the *Catalog of Federal Domestic Assistance 2012*, and prior editions, and updated in July, 2013 based on information found on the *Catalog* website found at <https://www.cfda.gov>. The tables offer a general perspective of government funding for specific programs and agencies, in relation to one another and to other federal activities. Such a perspective can be useful in several ways to persons or organizations interested in certain programs and in government assistance, including:

- Having identified programs meeting given needs, prospective applicants can use the tables to compare relative funding levels.
- Tables 1 and 2 show funding levels for four federal fiscal years. To our knowledge tables compiled specifically for the domestic assistance programs exist nowhere else—i.e., apart from the costs of other administering agency functions. Perhaps such a compilation adds a new dimension to perspectives of federal domestic assistance.

Important Note on Unavailable Information

In recent years, some departments or agencies have failed to provide updates to funding levels for certain programs and, in some cases, have failed to provide updates to funding levels for all programs administered by that department or agency. For instance, the DEPARTMENT OF VETERANS AFFAIRS has not updated funding levels for some of its largest programs, and the SOCIAL SECURITY ADMINISTRATION has not updated funding levels for any of its programs.

For this reason, we have eliminated the table of the fifty largest domestic assistance programs and the table of the fifty smallest domestic assistance programs to avoid confusion caused by this lack of information.

Important Notes on the Tables, Footnotes

Certain inconsistencies in the source material cannot be corrected. Therefore, the tables should be used only as a general guide to the availability of funding.

In Table 2, the first two digits in the five-digit number preceding the name of the administering agency correspond to the program number series identifying programs in Part II—e.g., 11.000 preceding DEPARTMENT OF COMMERCE encompasses all department programs including administrative sub-units.

The following footnotes are employed:

- * amount shown is a “credit” rather than an actual cash outlay. In the tables, amounts loaned or insured by the government are classified as credits.
- (a) funding for the program cannot be separately identified from other agency expenses.
- e amount was estimated in the source material, the significance of which is discussed in Part I.
- \i includes funding for this and for one or more other programs; program descriptions in Part II explain such cases.
- (n) program did not exist during the reported fiscal year.
- (nr) the administering agency did not provide funding levels for the reported fiscal year, which differs from the agency reporting no funding in which case a zero is used.
- (o) funding is included in an amount reported for another program, as noted in the Part II program descriptions.
- \p includes value of property or goods awarded; such amounts are not necessarily appropriated funds.
- \r program supports or is supported by a revolving fund.
- \t program includes support from or is supported by a federal trust fund.
- \u user charges, fees, or other nonfederal funds help support the program, including loan repayments; amounts shown are not necessarily or entirely appropriated funds.
